Your affiant conducted an investigation and received the following information:

Your affiant has been an Urbandale Police Officer for 11 years. I have been assigned the Criminal Investigation Division for three years. I am a certified police officer and a graduate of Iowa Law Enforcement Academy.

On November 2, 2016, at approximately 0105 hours, Urbandale Police Officer Zachary McDowell, who lives approximately two blocks from the scene, telephoned 9-1-1 (Westcom Dispatch) from his residence that he had heard gunfire in the vicinity of 70th and Aurora.

Immediately thereafter, Westcom received a call from a ^{Russell Cheatem} civilian reporting that he was at the scene of 70th and Aurora. He reported that he lives at the residence at the northeast corner of 70th and Aurora (4201 70th). He reported that he had heard what he believed to be 9-10 gunshots. He looked out the window and saw an Urbandale squad car parked in the middle of the intersection. He saw an individual he described as a white male, approximately forty years of age, approach the squad car on foot, then turn around, walk to a dark green or black pickup truck with a mismatched topper with apparent construction-work gear, parked on the southeast corner of the intersection, and drive off to the east. The caller stated that when he observed that the squad car was not moving, he walked to the car to investigate, observed bullet holes in the driver's side window. He approached the car, opened the driver's door and observed an unresponsive uniformed police officer in the driver's seat. He further reported that as he approached the squad car he heard the sound of multiple gunshots to the southeast and observed that it sounded like the same weapon. Officers arrived at 70th & Aurora to find Urbandale Police Officer Justin Martin unresponsive in the squad car. Medics responded and declared him dead at the scene
DETECTIVE COOK IDENTIFIED SHELL CASINGS FOUND AT THE SCENE AS .223 SHELL CASINGS.

At approximately 0110 Des Moines P.D. Sergeant Anthony Beminio was among officers tripped in response to shots fired in Urbandale, adjacent to the west side of Des Moines. Sergeant Beminio was parked on Sheridan at Merle Hay Drive, watching for the described suspect vehicle. Minutes later, officers who were dispatched to the area discovered Sergeant Beminio's squad car sitting at that intersection. They approached and opened the door to find Sergeant Beminio with apparent gunshot wounds and unresponsive. Medics responded and transported Beminio to Methodist Hospital, where he was declared dead.

Scott Michael Greene has recently interacted with authorities in Urbandale, Iowa. On Friday, October 14, 2016, Scott Michael Greene was involved in an incident at the Urbandale High School football game which culminated in Greene being escorted from the premises by a uniformed police officer. On October 16, 2016, officers were called to the residence at 3400 70th in response to a report from Scott Greene of a domestic assault by his mother, Patricia Greene. Urbandale police have been called to that residence on domestic disturbance reports on two

occasions since that date (on 10/17 and 10/18). On October 29 at 4:00 a.m., Scott Greene submitted a lengthy, rambling "compliment" on the Urbandale P.D. website apologizing for his recent conduct, claiming that he has PTSD, and stating that they would not be hearing from him much anymore. On November 1, Greene appeared in Polk County District Court in connection with the multiple domestic disturbances that had occurred at the residence that he shares with his mother (Patricia Greene) and his daughter. At this court proceeding, Scott Greene was ordered out of the residence.

After these shootings, Urbandale PD Detective Don Vestal contacted the teenage daughter of Scott Greene via telephone. She stated that she was asleep at the residence at the time of the call. She reported to the detective that she heard her father Scott Greene leave the residence at approximately midnight, hearing the door open and shut and hearing the pickup truck start up and leave. The detective asked her if her father was home, at which time she went downstairs to check his bedroom, found a light on, found his cell phone, and found lying on the bed a long black case that she knows to house a shotgun. She also stated that he does own an M-4 rifle (a high-powered .223 caliber rifle), an M-9 handgun and a Glock handgun.

A check of Greene's drivers license information, and a police database, shows his residence is listed as 3400 70th in Urbandale, and it is also known by Urbandale officers that Scott Green resides at that address.

The vehicle described as Dark blue 2011 Ford F-150, bearing Iowa Plate 780YFR and registered to Scott Michael Greene at 3400 70th Street, Urbandale, Iowa; VIN 1FTMF1CM0BKD11035. is requested pursuant to this search warrant based on reports that a dark pickup driven by the assailant was seen at the Urbandale crime scene at the time of that incident.

Images (photographic, videotaped and/or electronic) from the item(s) seized as requested in this application are relevant to this investigation to document the condition and location of the items seized at the time they were seized.

Based on my training and experience, I also know that clothing items worn by those involved in the commission of an assault often contain evidence of the victim's blood, blood spatter and other bodily fluids or specimens which may contain DNA.

Firearm evidence is sought because these crimes were committed by the use of a firearm or firearms. Cell phones and computers and other recording and communicating media are sought because the suspect is known to have communicated regarding his interactions with authorities, as noted above.

The buccal swabs and trace evidence including fingerprints, fingernail scrapings, DNA, blood, and/or blood stains or spatter sought by this warrant is the type of evidence which may lead to the identification of the individuals involved in this criminal activity.

Full body photographs sought may show wounds, injuries or other evidence which indicates the identified individuals' involvement in the describe altercations.
