AFFIDAVIT

STATE OF IOWA, STORY COUNTY

I, the undersigned, being duly sworn, state that all facts contained in this Complaint and Affidavit, known by me or told to me by other reliable persons form the basis for my belief that the defendant committed this crime

State all facts and persons relied upon supporting elements of alleged crime

On 2/23/2017 at approximately 0117 hours I, Officer Hicks (#433), responded to 3522 Frederiksen Court in reference to a call for the police

where it was unclear, exactly, was happened but a fight with blood present was reported. I arrived on scene and contacted the defendant.

He was standing in the hallway outside his apartment, looking at his left hand. Defendant stated he was bitten by his live-in girlfriend, whom he stated has been living with him in his apartment since January. Defendant stated they both got into a mutual fight over social media posts and broke each other's cell phones. Defendant had a small laceration on the skin between his left thumb and his left index finger. Defendant told me he and the victim have a sexually intimate relationship and she came from Florida to stay with him. Defendant told me the victim has one of the bedrooms in the 4-bedroom apartment where she keeps her belongings (clothes, etc.). I also noted the victim's clothing in the defendant's bedroom. Defendant told me he had to push the victim away, hold her back, and stop her during the fight, specifically stating she was trying to damage his laptop in addition to his cell phone, so he prevented her from doing that and hid his laptop in the island in the kitchen of the apartment's common area. Defendant told me his hand and arm were never grabbed and pulled to the victim's mouth, and told me he was bitten while holding the victim down; the defendant was animated when telling me these details and extended both of his arms and hands while demonstrating this for me. He also told me he wiped blood on the victim's face. Defendant would later tell me he had to lean on her after pushing her down onto the couch in the common area, and hold her down. There was a barstool laying on its side in the common area, which the defendant told me was a result of the struggle between the defendant and the victim.

I spoke with the victim who is the defendant's girlfriend, has been living with him since halfway through January, and they share a sexually intimate relationship. She stated the defendant and she were laying in bed, and they were arguing over posts on social media where people from back home in Florida were commenting. Then, the defendant began to pull on the covers in the bed and crowd the victim in the twin bed of the defendant's bedroom. The victim told me they went back and forth, arguing over music they were playing from each other's phones, which further irritated the argument they were having previously. A fight broke out where they got a hold of each other's phones; the defendant had the victim's phone in the common area and was throwing it, breaking it. The victim had the defendant's phone in the bedroom and damaged it. The victim was not able to remember how she got from the bed to the living room, but stated she was grabbed by her hair, indicating the right, front portion of her skull is where she was grabbed, holding her hair as she spoke. As I spoke with the victim I noticed she had a swollen, upper lip on the left side; she told me she could feel it with her tongue but was not aware it had happened, or how it happened. I saw a red/pink/purple mark the approximate size of a nickel, or quarter, on her right cheek. The victim tried to wipe it off but I told her it looked like a deep bruise or a deep tissue scratch, and it was below the skin. The victim also had two red marks, at the time I was looking, one was behind her left ear and the other was on the left side of the back of her neck. The victim had some dried blood on her right hand as well. The victim also had red marks and some darkened marks on the skin around the left side of her neck, and she had a scratch with some dried blood on her left clavicle. The victim was reluctant to share details with me, telling me she didn't want the defendant to lose what he has going in his athletic career.

Defendant was placed under arrest and transported to ISU Police for processing.

I asked officers to remain on scene and speak with the victim, and continue to monitor the victim's condition. The victim spoke with officers and admitted the defendant used his left and his right hand, around her neck/throat to strangle her. Paramedics were requested back to the scene to evaluate her. The victim's voice became more raspy and softer as the conversations continued. The victim told officers she could not remember how she got from the couch to the floor of the common area near the kitchen, and she had trouble breathing due to the force of the defendant's hands on her neck/throat area. The victim could not remember if she lost consciousness but articulated she "saw stars" when speaking with an officer who remained on scene with her. The victim reported recurring nausea that increased as she continued speaking with officers.

Defendant was subsequently transported to the Story County Jail where he was lodged.
